(Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative WINSOR of Norway; Cosponsored by Representative KNEELAND of Easton, Senator MICHAUD of Penobscot. Referred jointly to Joint Standing Committee on Appropriations and Financial Affairs and Joint Standing Committee on Transportation. Public Hearing 03/07/00. Majority (OTP-AM) Accepted 04/06/00.
