LD 2573 / SP1005

An Act to Prohibit Persons Under 21 Years of Age from Purchasing Handguns. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Senator PINGREE of Knox; Cosponsored by Representative ROWE of Portland and Senators: DOUGLASS of Androscoggin, GOLDTHWAIT of Hancock, RAND of Cumberland, TREAT of Kennebec, Representatives: BRENNAN of Portland, DUDLEY of Portland, ETNIER of Harpswell, SAXL of Bangor. Referred to Joint Standing Committee on Criminal Justice. Public Hearing 03/06/00. House: Adhere to Indefinite Postponement 04/11/00; Senate: Conference Committee 04/11/00. Final Disposition: Died Between Houses 04/11/00.
