An Act to Restore the Chaplaincy in the Maine Correctional Center in South Windham. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative McKEE of Wayne; Cosponsored by Senator KONTOS of Cumberland and Representatives: BAKER of Bangor, JOY of Crystal, MADORE of Augusta, MARTIN of Eagle Lake, POVICH of Ellsworth, TOBIN of Windham, Senators: LAWRENCE of York, NUTTING of Androscoggin. Referred to Joint Standing Committee on Criminal Justice. Public Hearing 03/06/00. OTP Accepted 03/23/00. Final Disposition: Indefinitely Postponed 04/27/00.
