An Act to Establish Consistent Requirements in Maine State Retirement System Plans for Minimum Creditable Service for Eligibility to Receive Retirement Benefits. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative HATCH of Skowhegan; Cosponsored by Senator DOUGLASS of Androscoggin and Representatives: CARR of Lincoln, DUPLESSIE of Westbrook, MATTHEWS of Winslow, McDONOUGH of Portland, SAMSON of Jay, TOWNSEND of Portland, Senators: DAVIS of Piscataquis, LaFOUNTAIN of York. Referred to Joint Standing Committee on Labor. Public Hearing 03/20/00. Majority (OTP-AM) Accepted 04/11/00. Amended by: CA H-1110. Final Disposition: Enacted, Signed 05/05/00, PUBLIC LAWS, Chapter 756.
