Presented by Senator PINGREE of Knox; Cosponsored by Representative CAMPBELL of Holden and Senator MURRAY of Penobscot, Representatives: BAGLEY of Machias, DUGAY of Cherryfield, McNEIL of Rockland, PIEH of Bremen, POWERS of Rockport, SAVAGE of Union, SAXL of Bangor. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 03/24/00. Majority (OTP-AM) Accepted 04/28/00. Amended by: CA S-757. Final Disposition: Enacted, Signed 05/17/00, PUBLIC LAWS, Chapter 787.
