An Act to Discourage Environmental Terrorism. Presented by Representative CLARK of Millinocket; Cosponsored by Representatives: BRYANT of Dixfield, CARR of Lincoln, DUNLAP of Old Town, GOODWIN of Pembroke, McGLOCKLIN of Embden, USHER of Westbrook, Senators: DAVIS of Piscataquis, YOUNGBLOOD of Penobscot. Referred to Joint Standing Committee on Criminal Justice. Public Hearing 03/29/01. House: Indefinitely Postponed 05/15/01. Senate: Majority (ONTP) Accepted 05/30/01. Final Disposition: Died in Concurrence 5/30/01.
