An Act to Provide Public Employees Equal Access to Personnel Files. Presented by Representative HUTTON of Bowdoinham; Cosponsored by Senator EDMONDS of Cumberland and Representatives: BOUFFARD of Lewiston, BRYANT of Dixfield, BUNKER of Kossuth Township, DUPLESSIE of Westbrook, HATCH of Skowhegan, PATRICK of Rumford, PINEAU of Jay, USHER of Westbrook. Referred to Joint Standing Committee on Labor. Public Hearing 04/03/01. OTP-AM Accepted 05/08/01. Amended by: CA H-319. House: Enacted 05/14/01, Insist on Enactment 05/17/01. Senate: Indefinitely Postponed 05/17/01, Adhere to Indefinite Postponement. Final Disposition: Died Between Houses 05/18/01.
