An Act to Make the Unemployment Insurance Program More Responsive to the Needs of Today's Workforce. Presented by Representative MATTHEWS of Winslow; Cosponsored by Senator EDMONDS of Cumberland and Representatives: BUNKER of Kossuth Township, DUPLESSIE of Westbrook, ESTES of Kittery, HUTTON of Bowdoinham, PINEAU of Jay, TARAZEWICH of Waterboro. Referred to Joint Standing Committee on Labor. Public Hearing 04/17/01. Majority (OTP-AM) Accepted 04/03/02. Amended by: CC H-839, HB/CC H-1027. Enacted 04/08/02. Vetoed by Governor 04/11/02. Final Disposition: Veto Sustained 04/24/02.
