Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 03/23/01. Majority (OTP-AM) Accepted 06/20/01. Recommitted to Joint Standing Committee on Appropriations and Financial Affairs. Final Disposition: Ought Not to Pass Pursuant to Joint Rule 310 03/25/02.
