An Act to Require Parental Notification of Abortion. Presented by Representative MacDOUGALL of North Berwick; Cosponsored by Senator DAVIS of Piscataquis and Representatives: CRESSEY of Baldwin, DAVIS of Falmouth, FOSTER of Gray, KASPRZAK of Newport, MENDROS of Lewiston, SHIELDS of Auburn, SNOWE-MELLO of Poland, WATERHOUSE of Bridgton, Senator YOUNGBLOOD of Penobscot. Referred to Joint Standing Committee on Judiciary. Public Hearing 03/29/01. Final Disposition: Majority (ONTP) Accepted 05/02/01.
