LD 1504 / SP0450

An Act to Authorize Department of Transportation Bond Issues in the Amount of \$61,600,000 to Match Available Federal Funds for Improvements to Highways and Bridges, Airports, Public Transit and Ferry Facilities; Development of Rail, Trail and Marine Infrastructure; and Improvements to Intermodal Facilities Statewide. (GOVERNOR'S BILL). Presented by Senator MICHAUD of Penobscot; Cosponsored by Representative FISHER of Brewer and Senators: BENNETT of Oxford, GOLDTHW AIT of Hancock, O'GARA of Cumberland, SAVAGE of Knox, Representatives: BERRY of Livermore, COLLINS of Wells, MCKENNEY of Cumberland, WHEELER of Bridgewater. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 03/23/01. OTP-AM Accepted 06/22/01. Amended by: CA S-361. Enacted, Signed 06/27/01, P & S LAWS, Chapter 38. Final Disposition: Approved in Referendum 11/06/01 (In favor: 162,071; Opposed: 56,407).
