LD 1663 / HP1222

Original Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$17,000,000 to Construct and Upgrade Water Pollution Control Facilities, to Limit Water Pollution Discharges from Maine Farms and Construct Agricultural Storage Facilities, to Remediate Municipal Solid Waste Landfill, to Clean up Tire Stockpiles and to Make Water System Improvements. New Title: An Act to Authorize a General Fund Bond Issue in the Amount of \$17,200,000 to Construct and Upgrade Water Pollution Control Facilities, to Remove Discharges, to Remediate Municipal Solid Waste Landfills, to Clean up Tire Stockpiles, to Make Drinking Water System Improvements and to Assist Municipalities in Building and Upgrading Infrastructure for Public Health and Safety. (GOVERNOR'S BILL). Presented by Representative COWGER of Hallowell; Cosponsored by Senator MARTIN of Aroostook and Representatives: COLLINS of Wells, DUPLESSIE of Westbrook, Senator CARPENTER of York. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 04/18/01. Majority (OTP-AM) Accepted 06/19/01. Amended by: CA (Changed Title) H-727, HA/CA (Changed Title) H-745. Enacted, Signed 06/20/01, P & S LAWS, Chapter 33. Final Disposition: Approved in Referendum 11/06/01 (In favor: 140,584; Opposed: 76,514).
