LD 1707 / SP0549

An Act to Authorize a General Fund Bond Issue in the Amount of \$15,000,000 to Capitalize the School Revolving Renovation Fund for Repairs and Improvements in Public School Facilities to Address Health, Safety and Compliance Deficiencies, General Renovation Needs and Learning Space Upgrades. (GOVERNOR'S BILL). Presented by Senator MITCHELL of Penobscot; Cosponsored by Representative RICHARD of Madison and Senators: MICHAUD of Penobscot, ROTUNDO of Androscoggin, SMALL of Sagadahoc, Representatives: BELANGER of Caribou, DESMOND of Mapleton, STEDMAN of Hartland, TESSIER of Fairfield, WATSON of Farmingdale. Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 04/18/01. OTP-AM Accepted 06/18/01. Amended by: CB S-358. Enacted, Signed 06/28/01, P & S LAWS, Chapter 41. Final Disposition: Approved in Referendum 11/06/01 (In favor: 149,580; Opposed: 68,471).
