An Act to Prohibit the Misbranding of Genetically Engineered Food. Presented by Senator KILKELLY of Lincoln; Cosponsored by Representative GOOLEY of Farmington and Senators: EDMONDS of Cumberland, LaFOUNTAIN of York, McALEVEY of York, NUTTING of Androscoggin. Representatives: PATRICK of Rumford, USHER of Westbrook. Referred to Joint Standing Committee on Agriculture, Conservation and Forestry. Public Hearing 04/12/01. Majority (OTP-AM) Accepted 05/17/01. Amended by: CA S-201. Final Disposition: Enacted, Signed 05/31/01, PUBLIC LAWS, Chapter 334.
