An Act to Permit the Town of Atkinson to Deorganize. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Senator DAVIS of Piscataquis. Referred to Joint Standing Committee on State and Local Government. Public Hearing 01/16/02. Majority (OTP-AM) Accepted 02/27/02. Amended by: CA S-437. Final Disposition: Enacted, Signed 03/28/02, P & S LAWS, Chapter 59.
