An Act to Ensure the Fair Collection of Overpayments. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative SIMPSON of Auburn; Cosponsored by Senator LONGLEY of Waldo and Representatives: COLWELL of Gardiner, DUDLEY of Portland, HALL of Bristol, LAVERRIERE-BOUCHER of Biddeford, MURPHY of Berwick, O'BRIEN of Lewiston, PATRICK of Rumford, Senator DOUGLASS of Androscoggin. Referred to Joint Standing Committee on Health and Human Services. Public Hearing 01/31/02. OTP-AM Accepted 03/12/02. Amended by: CA H-884.
