An Act Regarding the Repatriation of Native American Remains. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative SOCTOMAH of the Passamaquoddy Tribe; Cosponsored by Representatives: COTE of Lewiston, GERZOFKY of Brunswick, HAWES of Standish. LORING of the Penobscot Nation, McKEE of Wayne, TWOMEY of Biddeford. Referred to Joint Standing Committee on Health and Human Services. Re-refer Accepted 01/22/02. Re-referred to Joint Standing Committee on Judiciary. Public Hearing 02/05/02. Majority (OTP-AM) Accepted 03/25/02. Amended by: CA H-975. Final Disposition: Enacted, Signed 04/03/02, PUBLIC LAWS, Chapter 601.
