An Act to Safeguard Volunteer Firefighters' Regular Employment. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative HUTTON of Bowdoinham; Cosponsored by Senator KILKELLY of Lincoln and Representatives: BRYANT of Dixfield, HALL of Bristol, SMITH of Van Buren. TARAZEWICH of Waterboro, TRAHAN of Waldoboro, Senators: BROMLEY of Cumberland, EDMONDS of Cumberland, TREAT of Kennebec. Referred to Joint Standing Committee on Labor. Public Hearing 01/15/02. Majority (OTP-AM) Accepted 04/02/02. Amended by: CB H-947, SA/CB S-536. Final Disposition: Enacted, Signed 04/11/02, P & S LAWS, Chapter 70.
