LD 1959 / HP1462

An Act to Eliminate Department of Professional and Financial Regulation, Bureau of Insurance Travel Restrictions for Obtaining Health Care. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative MAYO of Bath; Cosponsored by Senator EDMONDS of Cumberland and Representatives: CUMMINGS of Portland, DUDLEY of Portland, ETNIER of Harpswell, FULLER of Manchester, GLYNN of South Portland, O'NEIL of Saco, SAXL of Portland, SULLIVAN of Biddeford. Referred to Joint Standing Committee on Banking and Insurance. Public Hearing 01/15/02. House: Adhere to Indefinite Postponement 04/04/09. Senate: Engrossed as Amended. Final Disposition: Died Between Houses 04/03/02.
