An Act to Clarify the Status of Retirees Who Return to Service Under the Maine State Retirement System. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative NORTON of Bangor; Cosponsored by Senator EDMONDS of Cumberland and Representatives: CUMMINGS of Portland, DAVIS of Falmouth, HUTTON of Bowdoinham, MATTHEWS of Winslow, PARADIS of Frenchville, SULLIVAN of Biddeford, TARAZEWICH of Waterboro, Senator SAWYER of Penobscot. Referred to Joint Standing Committee on Labor. Public Hearing 01/18/02. OTP-AM Accepted 03/11/02. Amended by: CA H-874. Final Disposition: Enacted, Signed 03/25/02, PUBLIC LAWS, Chapter 557.
