LD 1988 / SP0729

Original Title: An Act to Increase the Length of Time in Which a Retired State Employee May Add a Dependent to the Employee's Maine State Health Insurance Plan. New Title: An Act to Increase the Opportunities of Retired State Employees to Enroll a Spouse or Dependents in the Maine State Health Insurance Plan. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.)
