An Act to Establish the Asthma Prevention and Control Program in the Department of Human Services, Bureau of Health. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative FULLER of Manchester; Cosponsored by Senator TURNER of Cumberland and Representatives: DAIGLE of Arundel, DUDLEY of Portland, JACOBS of Turner, KANE of Saco, MAYO of Bath, NORTON of Bangor, TWOMEY of Biddeford, Senator CATHCART of Penobscot.
