Original Title: An Act to Provide funding for the Advisory Commission on Women Veterans. New Title: Resolve, Directing the Department of Defense, Veterans and Emergency Management to Make Recommendations to the Legislature to Provide Increased Outreach Activities for Women Veterans. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.)
