An Act to Repeal the Retroactive Effect of Changes Made to the Subdivision Laws. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative SNOWE-MELLO of Poland; Cosponsored by Senator SAWYER of Penobscot and Representatives: CARR of Lincoln, COLWELL of Gardiner, CUMMINGS of Portland, DAVIS of Falmouth, LESSARD of Topsham, MAYO of Bath, RICHARDSON of Brunswick, WESTON of Montville, Senator DAVIS of Piscataquis.
