An Act to Clarify the Law Governing Unlawful Solicitation to Benefit Law Enforcement Agencies. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Senator SMALL of Sagadahoc; Cosponsored by Representative PEAVEY of Woolwich and Senators: DAVIS of Piscataquis, McALEVEY of York, Representatives: CARR of Lincoln, MUSE of South Portland, BOWLES of Sanford, TOBIN of Dexter.
