An Act To Require Use of United States Citizens for Work with the Bureau of Parks and Lands. Presented by Representative JACKSON of Fort Kent; Cosponsored by Senator MARTIN of Aroostook and Representatives: CARR of Lincoln, JOY of Crystal, LUNDEEN of Mars Hill, PINEAU of Jay, SMITH of Van Buren, Senators: BRYANT of Oxford, KNEELAND of Aroostook, STANLEY of Penobscot. Referred to Joint Standing Committee on Agriculture, Conservation and Forestry. Public Hearing 02/24/03. Re-referred to Joint Standing Committee on Labor. Public Hearing 05/07/03. Majority (OTP-AM) Accepted 05/21/03. Amended by: CA H-402. Enacted. Vetoed by Governor 06/10/03. Final Disposition: Veto Sustained 06/10/03.
