RESOLUTION, Proposing an Amendment to the Constitution of Maine To Change the Assessment of Lands Used for Long-term Ownership. Presented by Representative PERCY of Phippsburg; Cosponsored by Senator MAYO of Sagadahoc and Representatives: ADAMS of Portland, JACKSON of Fort Kent, KAELIN of Winterport, LERMAN of Augusta, MILLS of Cornville, PARADIS of Frenchville, PINGREE of North Haven, Senator HATCH of Somerset. Referred to Joint Standing Committee on Taxation. Public Hearing 04/15/03. House: Conference Committee 04/29/04. Senate: Insist on Failed Engrossment 04/30/04. Final Disposition: Died Between Houses 04/30/04.
