An Act To Provide That Employee Terminations by Any Company That Receives Monetary Benefits from the State Require Just Cause. Presented by Representative SULLIVAN of Biddeford; Cosponsored by Senator EDMONDS of Cumberland and Representatives: COWGER of Hallowell, LAVERRIERE-BOUCHER of Biddeford, PINGREE of North Haven, SMITH of Van Buren. Referred to Joint Standing Committee on Labor. Public Hearing 03/27/03. House: Enactment Failed 05/29/03. Senate: Indefinitely Postponed 05/29/03. Final Disposition: Died in Concurrence 05/29/03.
