An Act To Make Retirement Benefits More Equitable by Imposing a Surcharge on Income from Congressional Retirement Benefits. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Senator DAVIS of Piscataquis; Cosponsored by Senators: STANLEY of Penobscot, NASS of York, SHOREY of Washington, Representatives: ANNIS of Dover-Foxcroft, BOWLES of Sanford, BRUNO of Raymond, CARR of Lincoln, CLARK of Millinocket, GOODWIN of Pembroke, TARDY of Newport.
