Presented by Representative CLARK of Millinocket; Cosponsored by Senator DAVIS of Piscataquis and Representatives: CARR of Lincoln, DUNLAP of Old Town, GOODWIN of Pembroke, JENNINGS of Leeds, PATRICK of Rumford, USHER of Westbrook, Senator EDMONDS of Cumberland. Referred to Joint Standing Committee on Taxation. Public Hearing 01/20/04. Minority (OTP-AM) Accepted 03/29/04. Amended by: CA H-755, HA H-813. Final Disposition: Indefinitely Postponed 04/27/04.
