An Act To Prohibit the Federal Government from Owning Property in the State Not Specifically Authorized in the United States Constitution. Presented by Representative JOY of Crystal; Cosponsored by Representatives: CROSTHWAITE of Ellsworth, FLETCHER of Winslow, JODREY of Bethel, RICHARDSON of Skowhegan, SAVIELLO of Wilton, SHERMAN of Hodgdon, VAUGHAN of Durham, Senator WOODCOCK of Franklin. Referred to Joint Standing Committee on State and Local Government. Public Hearing 01/24/05. Final Disposition: Majority (ONTP) Accepted 03/22/05.
