An Act To Authorize, Subject to State Referendum, a Tribal Commercial Track and Slot Machines in Washington County. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative MOORE of the Passamaquoddy Tribe. Engrossed Without Reference 06/14/05. Enacted 06/17/05. Vetoed by Governor 01/10/06. Final Disposition: Veto Sustained 01/10/06.
