Original Title: An Act To Streamline Criteria for Municipal General Assistance for Heating and Utility Assistance. New Title: Resolve, Directing the Department of Health and Human Services To Establish a Working Group To Examine Ways for Municipalities To Distribute More Heating Assistance. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative SCHATZ of Blue Hill; Cosponsored by Senator DAMON of Hancock and Representatives: HOGAN of Old Orchard Beach, PINGREE of North Haven. Referred to Joint Standing Committee on State and Local Government. Public Hearing 01/30/06. Majority (OTP-AM) Accepted 03/09/06. Amended by: CA (Changed Title) H-790. Final Disposition: Finally Passed, Signed 03/28/06, RESOLVE LAWS, Chapter 146.
