Original Title: An Act To Clarify the Unemployment Laws Relating to Subcontractors.
New Title: Resolve, To Require the Department of Labor, in Consultation with Interested Parties, To Examine the Laws and Practices Regarding the Definition of "Employment" for Purposes of Unemployment Compensation. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative MILLS of Farmington; Cosponsored by Representative MOODY of Manchester, Senators: BARTLETT of Cumberland, BROMLEY of Cumberland, EDMONDS of Cumberland, SNOWE-MELLO of Androscoggin. Referred to Joint Standing Committee on Labor. Public Hearing 02/07/06. OTP-AM Accepted 04/06/06. Amended by: CB (Changed Title) H937. Final Disposition: Finally Passed, Signed 04/14/06, RESOLVE LAWS, Chapter 191.
