Original Title: An Act To Prevent State Taxpayers from Subsidizing Large Employers. New Title: Resolve, To Collect Information about Employer-based Health Coverage. Presented by Senator EDMONDS of Cumberland; Cosponsored by Representative CANAVAN of Waterville and Representatives: LERMAN of Augusta, WEBSTER of Freeport.
