Referred to Joint Standing Committee on Legal and Veterans Affairs. Public Hearing 03/06/06. Majority (OTP-AM) Accepted 03/28/06. Amended by: CA S-513, HA/CA H-895, SA/CA S-544. Final Disposition: Finally Passed, Signed 05/25/06, CON RES LAWS, Chapter 2. Approved by referendum, 11/07/06 (In favor: 270,922; Opposed: 229,749)
