Presented by Senator SMITH of Piscataquis. In Senate: Passed 02/05/08; Insisted 02/12/08. In House: Indefinitely Postponed in Non-concurrence 02/07/08; Adhered 02/12/08. Final Disposition: Died Between Houses 02/12/08.
