Presented by Senator GOODALL of Sagadahoc. Referred to Jt. Standing Comm. on Taxation. Public Hearing 05/05/09. OTP-AM Accepted 05/26/09. Amended by: CA S-188. Final Disposition: Emergency Finally Passed, Signed 06/09/09, RESOLVE LAWS, Chapter 116.

Joint Order, To Recall LD 1390 from the Governor's Desk to the House. Presented by Representative WATSON of Bath. In House: Passed 06/01/09, Voted to Adhere 06/03/09; In Senate: Indefinitely Postponed 06/03/09, Voted to Adhere 06/04/09. Final Disposition: Died Between Houses 06/04/09.
