An Act To Amend the Standards by Which Game Wardens May Stop All-terrain Vehicles when Operating on Private Property. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 203.) Presented by Representative SARTY of Denmark. Referred to Jt. Standing Comm. on Inland Fisheries and Wildlife. Public Hearing 01/19/10. Majority (OTP) Accepted 04/01/10. Final Disposition: Died Between Houses 04/06/10.
