LD 359 / HP0285

An Act To Authorize a General Fund Bond Issue for Wastewater and Drinking Water Revolving Loan Funds. Presented by Representative FLOOD of Winthrop. Referred to Jt. Standing Comm. on Appropriations and Financial Affairs. Public Hearing 10/24/11. Ought to Pass as Amended Accepted 05/16/12. Amended by: CA H-957. Enacted, Neither Signed nor Vetoed 05/29/12, PUBLIC LAWS, Chapter 695. Final Disposition: Approved in Referendum 11/06/12 (In favor: 432,813; Opposed: 253,561).
