LD 852 / SP0255

An Act To Authorize a General Fund Bond Issue To Support Maine's Natural Resource-based Economy. Presented by Senator TRAHAN of Lincoln. Referred to Jt. Standing Comm. on Appropriations and Financial Affairs. Public Hearing 02/23/12. Majority (Ought to Pass as Amended) Accepted 05/16/12. Amended by: CA S-576, SA/CA S-591. Enacted, Neither Signed nor Vetoed 05/29/12, PUBLIC LAWS, Chapter 696. Final Disposition: Approved in Referendum 11/06/12 (In favor: 418,555; Opposed: 270,301).
