An Act To Change Document Filing Fees for County Registries of Deeds. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative MOULTON of York. Referred to Jt. Standing Comm. on State and Local Government. Public Hearing 05/09/11. Majority (Ought to Pass as Amended) Accepted 03/23/12. Amended by: CA H-711, HA H-851. Enacted 04/10/12. Vetoed by Governor 04/20/12. Final Disposition: Veto Sustained 05/15/12.
