An Act To Raise the Speed Limit on Interstate 95 between the City of Old Town and the Town of Houlton. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative WILLETTE of Mapleton. Referred to Jt. Standing Comm. on Transportation. Public Hearing 05/12/11. Ought to Pass as Amended Accepted 06/02/11. Amended by: CA H-447. Final Disposition: Enacted, Signed 06/29/11, PUBLIC LAWS, Chapter 415.
