Original Title: Resolve, Directing the Department of Health and Human Services To Amend Its Rules Governing Electronic Benefits Transfer Cards To Require a Person To Show Photographic Identification When Using a Card. New Title: Resolve, Directing the Department of Health and Human Services To Submit an Application for a Waiver from the United States Department of Agriculture. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by Representative HARVELL of Farmington. Referred to Jt. Standing Comm. on Health and Human Services. Public Hearing 02/28/12. Majority (Ought to Pass as Amended) Accepted 03/28/12. Amended by: CA (Changed Title) H-817. Final Disposition: Finally Passed, Neither Signed nor Vetoed 04/12/12, RESOLVE LAWS, Chapter 155.
