Original Title: An Act To Establish the High-efficiency Biomass Pellet Boiler Rebate Program and the Home Heating Conversion Fund. New Title: Resolve, Directing the Public Utilities Commission To Study the Potential Benefits and Barriers Involved in Making Renewable Thermal Technologies Eligible for Qualification in Maine's Renewable Energy Portfolio Standard. Presented by Senator JACKSON of Aroostook. Referred to Joint Standing Committee on Energy, Utilities and Technology. Public Hearing 05/06/13. Re-referred to Joint Standing Committee on Appropriations and Financial Affairs. Report rejected. Amended by: SB (Changed Title) S-510. Enacted. Final Disposition: Veto Sustained 05/01/14.
