Presented by Senator PATRICK of Oxford. Referred to Joint Standing Committee on Labor, Commerce, Research and Economic Development. Public Hearing 02/25/14. Majority (OTP-AM) Report Accepted 03/27/14. Amended by: CA S-433. Enacted. Final Disposition: Veto Sustained 05/01/14.
