Public Hearing 03/27/14. OTP-AM Accepted 04/17/14. Amended by: CA S-555. Enacted. Veto Overridden 05/01/14, PUBLIC LAW, Chapter 596. Final Disposition: Approved in Referendum 11/04/14 (In favor: 362,225; Opposed: 222,560).
