Amended by: CA H-680. Carried Over: 07/16/15. Enacted, Signed 04/15/16, PUBLIC LAW, Chapter 479. Final Disposition: Approved in Referendum, 06/13/17 (In favor: 63,468; Opposed: 39,549).
