Referred to Joint Standing Committee on Appropriations and Financial Affairs. Public Hearing 06/05/15. Majority (OTP-AM) Report Accepted 06/30/15. Amended by: CA H-503, SA/CA S-340. Enacted, Unsigned 07/12/15, PUBLIC LAW, Chapter 337. Final Disposition: Approved in Referendum 11/03/15 (In favor: 151,695; Opposed: 67,160).
