LD 1430 / SP0538

An Act To Allow Hunters Whose Religion Prohibits Wearing Hunter Orange Clothing To Instead Wear Red. (Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 205.) Presented by President THIBODEAU of Waldo. Referred to Joint Standing Committee on Inland Fisheries and Wildlife. Public Hearing 05/26/15. In Senate: Minority (OTP-AM) Report Accepted, Engrossed as Amended by CA; Insisted. In House: Majority (ONTP) Report Accepted; Insisted. Conference Committee Failed to Agree. Final Disposition: Died Between Houses 06/30/15.
